



Coulee Dam Federal Credit Union Drawing Terms and Conditions eStatement

This Drawing is being administered and operated by Coulee Dam Federal Credit Union, P.O. Box 216 Coulee Dam, WA 99116.

Eligibility: The Drawing is open to a) existing Coulee Dam Federal Credit Union members, or b) natural born U.S. citizens or permanent and lawful residents who meet our eligibility requirements. You are eligible for membership if you live, work, worship or attend school in, and businesses and other legal entities in Douglas, Okanogan, Stevens, Pend Oreille, Ferry, and Grant counties. Or if you live, work, worship, or attend school in, and businesses and other legal entities located within a fifty mile radius of the Coulee Dam, WA post office. Entrants must be eighteen (18) years of age or older and must not be considered a minor at the time of entry.

The following persons are not eligible to enter the contest: Coulee Dam Federal Credit Union employees, volunteers and their immediate family members.

How to Enter: No purchase is necessary to enter nor will a purchase or deposit increase your chances of winning. To enter the drawing you must enroll in eStatements between July 1, 2020 and July 31, 2020. LIMIT ONE (1) ENTRY PER PERSON. If you desire to enter the Drawing other than by enrolling in eStatements you must print your name, address, age, mobile number, email address (if available) and the name "CDFCU eServices Drawing" on a 3"x 5" index card. Send the card to P.O. Box 216, Coulee Dam, WA 99116. CDFCU reserves the right to limit the number of entries you can send to one (1) per household. Each entry must be mailed and must be postmarked seven (7) days prior to drawing. Entries will not be acknowledged or returned. Neither CDFCU nor its employees, officers, volunteers or directors shall be responsible for lost, misdirected, incomplete, or illegible entries. All personal information collected will be treated in a manner consistent with CDFCU's Privacy Policy.

Drawing Period: There will be one (1) drawing period of July 1, 2020 to July 31, 2020 with a drawing date of August 3, 2020.

Prize: One randomly selected winner will be awarded a \$100 gift card. The winner will be notified by CDFCU. The winner need not be present to win and will be notified by phone and/or mail. If a winner cannot be contacted within five (5) business days, then such person will be disqualified and an alternate winner will be chosen.

The odds of being the prize winner depend on the total number of eligible entries received. The credit union does not have an estimate of the number of entries it will receive. The winner of the prize will be selected randomly from among all eligible entries that are received in accordance with these Terms and Conditions. All decisions are final and binding. Neither CDFCU nor its employees, officers, volunteers or directors shall be responsible for late, lost, misdirected, or unsuccessful efforts to notify winner.

Prize Conditions: CDFCU will report prize winnings to the appropriate state and federal agencies as required by law. Federal, state and local tax liability and any other expenses are the sole responsibility of the prize winner. The Drawing is void where restricted and/or prohibited. The Drawing prize is non-transferable, non-assignable and non-exchangeable.

Consent to Publicity and Release: By accepting a prize, the winner consents to the use of his or her name and likeness for publicity purposes without further compensation, unless prohibited by law. All entrants agree to release and hold harmless CDFCU, its employees, members, officers, volunteers and directors from any and all claims of any kind arising directly or indirectly from the Drawing, from any Drawing prize, or from any publicity regarding the Drawing.
